



AFFIDAVIT IN SUPPORT  
OF COMPLAINT

COUNTY OF Page }

I, David L. Dales, telephone number 712-322-1585; a member of the Iowa Division of Criminal Investigation being first duly sworn on oath, depose and state:

I am currently a Special Agent with the Iowa Division of Criminal Investigation and have been employed in this capacity for over 15 years. I have been assigned to the Major Crimes Unit since November 1998.


I have received extensive training in the area of criminal investigations during my law enforcement career. This training includes homicide investigation; death investigation; crime scene processing; evidence handling, collection, & packaging; firearms instructor certification, financial crime investigation; interview and interrogation; criminal intelligence techniques; gaming/background investigations; sex crime investigations; and missing persons recovery and investigations.

On Monday, June 14, 2010 at approximately 6:15pm an assault occurred in the prison yard at the Clarinda Correctional Facility, located in Clarinda, Iowa. The victim of the assault was 44 year old inmate named Alfred Eugene Myre. Myre was assaulted by three fellow inmates under the direction of a fourth inmate. The inmates are alleged to be members of an organized prison gang named "The Peckerwoods". One of the leaders of the gang, Martin Edward Dahlke, was observed directing inmates Richard Jason Martin, Jr., Jeremy John McIntosh and Rolland William Jacobsen to assault Alfred Myre. Inmate Dahlke was witnessed to have ordered the assault to begin and also ordered the assault to terminate. The assault was reported to have lasted approximately 30 seconds.

Witnesses observed inmates Martin, McIntosh and Jacobsen assaulting inmate Myre. Multiple inmates described the beating of Myre as one which included many heavy punches, all delivered to the torso area. Many of the heavy punches were delivered to the side and back of Myre. Witnesses described the beating's intensity by speaking of being able to hear the blows hitting Myre's body from all the way out in the baseball fields of the yard area.

After the assault, Myre was walked into the yard by Dahlke, where Myre sat down at one of the picnic tables located in the middle of the yard area. Soon after reaching the picnic area, Myre fell backwards, unconscious onto the ground. CPR was immediately performed by the DOC officers nearby. Myre died soon there after.

An autopsy was performed the following day at the Iowa State Medical Examiner's Office in Ankeny, Iowa. The results of the autopsy showed Myre died as a direct result of the assault. Myre had numerous internal injuries including a ruptured spleen which proved to be fatal.
