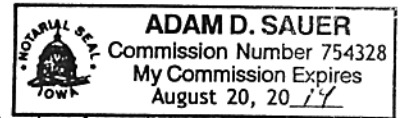



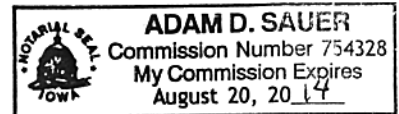

Attachment A – Affidavit

On November 19, 2010 THADDEUS JOHN ELLENBECKER, (DOB: 5-22-1977) did unlawfully take possession and control of property of another officer's Smith & Wesson M & P AR-15 rifle, which belonged to the Forest City Police Department. The rifle was taken from a locked car trunk of a Forest City Police Department vehicle. This was done with the intent to permanently deprive the Forest City Police Department and the Officer, of the rifle. The weapon was subsequently transported across state line, to Minnesota. Ellenbecker confessed to DCI agents on October 20th and 21st, of 2011 that he stole the rifle and transported it to his father's residence in Minnesota.

On October 1, 2011 THADDEUS JOHN ELLENBECKER, (DOB: 5-22-1977) did unlawfully intentionally place incendiary materials in the Forest City Police Department with the intent to damage or destroy the property. Ellenbecker did place an open flame in contact with combustible material (cardboard) and started the fire at the Forest City Police Department. Ellenbecker confessed to DCI agents on October 20th and 21st, of 2011, stating that he intentionally set the fire at the Forest City Police Department on October 1, 2011.
