The [Iowa Department of Public Safety](#) releases the names of missing persons on a weekly basis. The list for this week, released by [Commissioner Larry L. Noble](#), contains 113 entries. This includes only the names of persons reported missing since the last press release. Of those missing, 19 are adults and 94 are juveniles. 108 entries were canceled during this period. There are a total of 369 persons currently on file with the department; of these, 251 are juveniles and 118 are adults.

The Iowa missing persons file maintained by the [Missing Person Information Clearinghouse](#) of the Department of Public Safety consists of the names of people entered by law enforcement agencies into the data bank of the statewide computer network. Primary responsibility for the investigation of a case lies with the law enforcement agency receiving the report.

For each missing person on the list, the following data is provided: name, age, date of disappearance, entering agency, and type of incident. For those located, the list provides name, age and agency.

## Status or Incident Type

**I - Involuntary** A person of any age who is missing under circumstances indicating that the disappearance was not voluntary, i.e., abduction or kidnapping.

**E - Endangered** A person of any age who is missing under circumstances indicating that his/her physical safety is in danger.

**D - Disabled** A person of any age who is missing and under proven physical/mental disability or is senile, thereby subjecting himself/herself or others to personal and immediate danger.

**V - Catastrophe** A person of any age who is missing after a catastrophe. (ie. victims of disasters, such as tornadoes, etc.)

**R – Adult Other** A person not meeting the criteria for entry in any other category who is missing and 1) for whom there is a reasonable concern for his/her safety or 2) a person who is under age 21 and declared emancipated by the laws of the state when no other criteria for disability, endangered, involuntary or catastrophe victim apply.

**K - Familial Kidnap** A minor who is missing and has been declared unemancipated as defined by the laws of his/her state of residence and who has been abducted by non-custodial parent or relative.

**L - Lost/Wandered Away** A minor who is lost or has wandered away. This category does not include those persons taken by force or runaways.

**J - Juvenile** A person who is missing and not declared emancipated as defined by the laws of his/her state of residence and does not meet any of the entry criteria for disability, endangered, involuntary, catastrophe victim, parental abduction, or lost or wandered away.



## Reason for Cancellation

**C** – Arrested criminal charges

**D** – Other deceased

**E** – Error in record

**H** – Homicide victim

**P** – Picked up (no criminal charges)

**T** – Transfer of status

**U** – Unfounded report

**V** – Voluntarily returned

**W** – Whereabouts determined; person not returned
